VACANCY CIRCULAR

Subject: Filling up one of Joint Director (Public Relation) in Pay Level 11 under 7th CPC in NDMC on deputation basis.

New Delhi Municipal Council proposes to fill up one (01) post of Joint Director (Public Relation) in Pay Level 11 under 7th CPC, on deputation basis for a period of 01 year which is extendable upto 3 years Or as per extant guidelines of DoP&T. The eligibility criteria required for the posts are as under:-

Officers under the Central/State Government/Union Territories/recognized Research Institutions/Public Sector Undertakings/autonomous Organizations:-

- (a) (i) Holding analogous posts on regular basis;
or
(ii) With 5 years regular service in posts in the Pay Level-10 of 7th CPC or equivalent; or
(iii) With 8 years regular service in posts in the Pay Level-8 of 7th CPC or equivalent:

and

- (b) Possessing the following educational qualifications and experience:

Essential

- i. Master's Degree of a Recognized University or equivalent;
- ii. Degree/Diploma in Journalism/Mass Communication from a recognized University/Institution or equivalent.
- iii. 5 years experience of Public Relations Work.

2.. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/deptt. of the Central Govt. shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.
