- (iii) Proficiency in the use of a variety of computer office applications, MS Word, MS Excel, Power Point or equivalent is must.

Tenure:

The appointment will be purely on contract basis initially for a period of one year. The tenure can be extended further up to 3 years depending upon performance of the candidate and requirement of the institute.

Job Profile:

This post holder will be required to perform following day to day administrative and technical work of the institute:

- (i) Should be able to prepare Preliminary Cost Estimate and Detailed Cost Estimate for original as well as maintenance work.
- (ii) Should be able to supervise all maintenance work carried out by institute employed workers / vendors.
- (iii) Should be able to prepare tender document
- (iv) Should be able to publish tender on e-Procure Portal and IIFT website.
- (v) Receipt opening and processing of tender for acceptance by the competent authority.
- (vi) Should have vast experience of Contract Management.
- (vii) To verify / prepare if required, vendor bills and process for approval of the competent authority.
- (viii) To liaison with the local authorities
- (ix) Should be well versed with GeM & GFR Rules & Regulations
- (x) Handling all kinds of e-procurement through GeM, CPP Portal, and other methods as per GFR.

Age: Should not be more than 62 Years as on last date of receipt of application.

Emoluments: Rs. 65,000 – 75,000/- p.m. all-inclusive lump sum remuneration based on qualification and experience shall be offered.
