1. **Qualification:** MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University / Institution and should have a valid registration with Delhi Medical Council. Must have not completed 03 years Senior Residency in any recognized institution including regular & adhoc period.
2. **Pay scale:** Rs.67700 – 208700 of level 11 plus allowances as admissible under the rules.
3. **Age limit for Senior Residents:** 45 years for Gen. and OBC candidate and age relaxation for SC/ST candidate as per rule.
4. In case of non-availability of candidate with PG Degree/Diploma, candidate with two years experience in the department of Obs & Gynae. And three years experience in the Department of Medicine will be considered.
5. In case of non-availability of fresh candidates, the candidates who have completed 3 years of Senior Residency may also be allowed to appear in the interview.
6. **Other conditions/requirements:**
  1. OBC/EWS certificate issued by Govt. of NCT of Delhi shall only be accepted and the same must have issued before the date of interview. Further, the OBC certificate must possess Non Creamy Layer certificate for the current year along with his/her caste certificate.
  2. In case of continuous **absence of more than 03 days**, the service shall be liable to be terminated with or without any prior notice.
  3. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
  4. No TA/DA will be paid for appearing in the interview.
  5. Hostel accommodation is mandatory for selected candidates subjected to availability.
